Privacy Policy of the
Altona Hockey Club, Inc.

PURPOSE:

The protection of personal information is important to Altona Hockey Club Inc. (AHC). AHC is committed to respecting individual's privacy and the protection of personal information.

This document sets out how AHC may collect, hold, and use personal information. By providing your personal information to AHC (either directly or through an affiliated organisation), you consent to its use, storage and disclosure in accordance with this Privacy Policy.

It intentionally reflects the provisions of the Hockey Victoria Privacy Policy to ensure consistency across organisations.

This policy replaces all previous Privacy Policy documents of the AHC.

1: Collection of Personal and Sensitive Information:

1.1: Why does AHC collect personal information?

"Personal information" is information or an opinion (including information forming part of a database), whether true or not, and whether recorded in material form or not, about an individual whose identity is reasonably apparent, or can be reasonably ascertained, from the information or opinion.

AHC collects personal information in order to properly and efficiently carry out its functions, including providing you requested products and services, and to facilitate the provision of marketing and promotion services that may be of interest to you.

AHC uses personal information only for the purposes for which it was provided and for directly related purposes (unless otherwise required by or authorised under law). AHC may state a more specific purpose at the point we collect your information. If you do not provide us with the information that it requests, AHC may not be able to provide you with our products or services.

1.2: What personal and sensitive information does AHC collect?

1.2.1: Personal Information

"Personal information" is information or an opinion (including information forming part of a database), whether true or not, and whether recorded in material form or not, about an individual whose identity is reasonably apparent, or can be reasonably ascertained, from the information or opinion.

The information collected by AHC about a particular person will vary depending on the circumstances of collection. It may include, but is not limited to, a person's contact details (name, email and/or postal address, phone number), date of birth, gender, credit card details, driver's license number, passport number, insurance details, employment history, qualifications or communication history with AHC or an affiliate organisation.

1.2.2: Sensitive Information

"Sensitive information" is a type of personal information that also includes information or an opinion about an individual's racial or ethnic origin, political opinions, membership of a political association, professional or trade association or trade union, religious beliefs or affiliations or philosophical beliefs, sexual preferences or practices, criminal record or health, genetic information or disability.

If it is reasonably necessary in the circumstances, AHC may also collect sensitive information such as your medical history, disability background or racial or ethnic origin.

Sensitive information is afforded a higher level of privacy protection than other personal information. Where you provide sensitive information to AHC, you also provide consent to AHC collecting it in accordance with this Privacy Policy, unless you tell us otherwise.

1.3: How does AHC collect and hold personal information?

Information may be collected when you:

1. become a member of AHC.
2. become a member of Hockey Victoria (HV).
3. subscribe to any publication of AHC, including electronic publications.
4. are selected or nominated for representation in an AHC hockey team.
5. provide details to AHC in an application, consent form, survey, feedback form or incident report.
6. access the AHC website.
7. contact AHC via email, telephone, fax or mail or engage with AHC via social media.
8. participate in any program, activity, competition or event run by AHC.
9. purchase merchandise, products or services from AHC or an authorised agent or licensee.
10. are elected or appointed to the Board or a committee of AHC; or
11. apply for employment or a volunteer position with AHC.

Personal information may also be collected where AHC is required to do so by law (for education, child protection, work health and safety laws, charitable collections, medical treatment or other legislation in Australia).

1.3.1: Providing information

If you do not provide some or all of the information that we request from you, this may affect AHC's ability to communicate with you or provide the requested products or services.

By not providing requested information, you may jeopardise your ability to participate in programs or competitions or apply for employment or volunteer positions with AHC or a HV Affiliate. If it is impracticable for AHC to deal with you as a result of you not providing the requested information or consent, AHC may refuse to do so.

1.3.2: Collection from third parties

AHC may collect personal information regarding a child from the parent or other responsible person associated with that child.

1.3.3: Information storage and protection

AHC and HV store information in different ways, including in paper and electronic form.

Much of the information HV collects from members and players is added to Hockey Australia's (HA's) National Database revolutioniseSPORT. When your information is entered into HA's database, the information may be combined or linked with other information held about you. HA's database is shared among HA, its State and Territory hockey associations and its clubs, with each organisation having access to information relevant to its members or registered players.

AHC also maintains paper and electronic records in its own database. AHC's membership database is one of the organisation's most valuable assets.

Security of personal information is important to AHC, HA and HV. HA has taken steps to protect the information held from misuse, loss, unauthorised access, modification or disclosure. Some of the security measures HA and HV use includes strict confidentiality requirements of their employees, volunteers, HV Affiliates and service providers, security measures for system access and security measures for the HV website.

2: Use and disclosure of personal Information:

2.1: How does AHC use and disclose personal information?

2.1.1: Use

AHC and third parties to whom we may disclose personal information in accordance with this Privacy Policy, may collect, hold, and use your personal information to:

1. verify your identity;
2. complete background checks;
3. research, develop, run, administer and market competitions, programs, activities and other events relating to hockey or other sports;
4. research, develop and market products, services, merchandise and special offers made available by us and third parties including but not limited to HV

member associations and clubs, other hockey associations or our licensees, suppliers and sponsors;

5. respond to emergency situations involving or requiring medical treatment;
6. administer, manage and provide you with access to the AHC and HV websites;
7. administer, manage and provide you with access to the HA National Database; and
8. keep you informed of news and information relating to various AHC, HV or hockey events, activities and opportunities via various mediums.

AHC may use health information to ensure that programs we operate are run safely and in accordance with any special health needs participants may require. Health information may also be kept for insurance purposes. In addition, we may use de-identified health information and other sensitive information, including individual's racial or ethnic origin, to carry out research, to prepare submissions to government, or to plan events and activities.

2.1.2: Disclosure

AHC may disclose your personal information to a range of organisations which include, but are not limited to:

1. HA, HV Affiliates and other organisations involved in hockey and sporting programs in Australia.
2. companies we engage to carry out functions and activities on AHC's behalf,
3. our insurers.
4. relevant sporting bodies such as the International Hockey Federation (FIH), Australian Sports Commission, Australian Olympic Committee, the Australian Sports Anti-Doping Authority, Australian Institute of Sport, the various State and Territory Institutes and Academies of Sport, the Australian Commonwealth Games Association, various National Sporting bodies, Federal and State Departments of Sport amongst others; and
5. in other circumstances permitted by law.

2.1.3: Direct marketing

AHC will use non-sensitive personal information to provide better services and for marketing purposes (including disclosure of such information to service providers).

If you do not wish to receive promotional material from AHC sponsors and third parties, you must advise AHC in writing or via the opt-out procedures provided in the relevant communication.

2.1.4: Other disclosures

In addition, AHC may also disclose personal information:

1. with your express or implied consent;
2. when required or authorised by law;
3. to an enforcement body when reasonably necessary; or
4. to lessen or prevent a threat to an individual or public health or safety.

2.1.5: AHC website

When you visit the AHC website, our systems may record certain information about your use of the site, including the web pages visited and the time and date of their visit. AHC uses this information to help analyse and improve the performance of the AHC website.

In addition we may use “cookies” on the AHC website. Cookies are small text files that assist our website retain user preferences to improve the experience of using our website. In some cases, the cookies that we use may collect some personal information. AHC will treat this information in the same way as other personal information we collect. You are free to disable cookies on your internet browser to prevent this

Information being collected; however, you will lose the benefit of the enhanced website experience that the use of cookies may offer.

Websites linked to the AHC website are not subject to AHC’s privacy standards, policies or procedures. AHC cannot take any responsibility for the collection, use, disclosure or security of any personal information that you provide to a third-party website.

3: Access and Correction of Personal Information

3.1: Accessing and seeking correction of information held by AHC

AHC will take all reasonable steps to ensure that the personal information it collects, uses or discloses is accurate, complete and up to date. However, we rely on the accuracy of personal information as provided to us both directly and indirectly. AHC relies on a process of periodic member information review to determine the quality of the information held in its own database.

We encourage you to regularly review and update your personal information. If you would like to access the personal information that we hold about you, please let us know by making a request via the contact details set out below. We will respond to your request for access within a reasonable period. If you find that the personal information, we hold about you is inaccurate, incomplete, or out- of-date, please contact us immediately and we will correct it.

3.2: Resolving privacy issues and complaints
